

Chairman Larry Morse called the regular meeting of the Board to order at 8:00 p.m. Trustees Larry Morse, Mark Reed, John McMahan, and Fiscal Officer Marie Rohrbaugh were also present. The Pledge of Allegiance was recited.

Chairman Larry Morse moved to approve the June 15, 2022 meeting minutes as presented, second by Trustee Mark Reed, 3 ayes, motion carried.

NAD: Reports were presented.

ZONING ADMINISTRATOR: The Chairman read the zoning report that was sent in by former Zoning Administrator Ron Folsom. The Board approved to receive applications until the end of this meeting. The Board will review the 3 applications received by the Fiscal Officer for the Zoning Administrator position.

ZONING COMMISSION: Commission Member Chuck Loya reported the commission is reviewing Dollar stores and the restrictions of building in a township and will check with other townships and cities. May not be able to restrict building unless ordinance is passed by trustees. Next meeting is July 18, 2022 at 7:30 p.m.

BOARD OF ZONING APPEALS: The Fiscal Officer reported the Board of Zoning Appeals held a meeting on July 5, 2022 at 6:30 p.m. regarding Pohto's Variance Appeal and filed a Variance Appeal from Chris Sheilds with the BZA.

TRUMBULL TOWNSHIP FIRE AND RESCUE: The Fire Chief reported 2 Motor Vehicle Accidents at SR 534 & 166 with no patient injuries. Chief Clay presented volunteer firefighter applications from Joe Kaminski and Steven Savage II for review, stating they have signed up for 36-hour training. Chairman Morse moved to accept Joe Kaminski's application for Volunteer Firefighter position. Second by Trustee Mark Reed, 3 ayes, motion carried. Chairman Morse moved to accept Steven Savage II's application for Volunteer Firefighter. Second by Trustee Mark Reed, 3 ayes, motion carried. The Fiscal Officer swore in Mr. Kaminski & Mr. Savage. Chief Clay presented Trustee Larry Morse's application for Assistant Fire Chief with his okay and recommendation. Trustee Mark Reed moved to accept Larry Morse's application as Assistant Fire Chief, roll call vote: Trustee Reed: yes, Trustee McMahan: no Chairman Morse: abstained, motion was defeated. Discussion followed should current Fire Chief resign would the Assistant Fire Chief take over as the New Fire Chief. Trustee McMahan stated he is ok with Trustee Morse taking care of the fire department but not as Assistant Fire Chief. Trustee Mark Reed moved to accept Trustee Larry Morse's application as a Volunteer Firefighter, second by Trustee McMahan, 2 ayes, motion carried. The Fiscal Officer swore in Mr. Morse.

ROAD AND BRIDGE: Road Superintendent Joe Sypniewski reported ditching and mowing are on going. He reported Jefferson Township is asking \$6,000 for their road drag maintainer as advertised in the OTA magazine. Road Superintendent will look at it tomorrow, stating

maintaining roads would be quicker with a two maintainer. Road Department spent a couple of hours weed whipping at the Old Town Hall.





The Chairman opened the floor for comments from others in attendance who desired to speak. Mrs. Knauff asked about spring cleanup. Trustee Mark Reed stated a possibly fall cleanup.
