

Chairman Larry Morse called the regular meeting of the Board to order at 8:00 p.m. Trustees Larry Morse, Mark Reed, Trustee John McMahan and Fiscal Officer Marie Rohrbach were also present. The Pledge of Allegiance was recited.

Trustee McMahan moved to approve the minutes as presented of the Board's regular meeting held on February 15, 2023, second by Trustee Reed, 3 ayes, motion carried.

NAD: No report.

ZONING ADMINISTRATOR: Administrator Niewiadomski reported a property split on SR 534 south of Boughner west side of road; issued new home permit to Hallgren's on Atkins; received inquiry from a realty company regarding property at Hoffman & SR 534 zoned residential; no response to message left from county prosecutor.

ZONING COMMISSION: Commission Member Loya reported having an organizational meeting; will be discussing dollars stores, solar panels, waiting for information on Airbnb rentals. Next meeting scheduled for March 20, 2023 at 7:30 p.m. at TTAB.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Fire Chief Berlinski reported receiving 6 calls last month; mutual aid responding to trees and wires down; equipment up and running; February 25, 2023 fire department auxiliary's soup drive went well served approximately 68 with a \$400.00 profit after expenses; possibly repeat in fall.

ROAD AND BRIDGE: Road Superintendent Sypniewski reported regular maintenance and tree trimming on going; International Truck #1 transmission line leaking; requesting create a form letter for replacing driveway pipes; someone living in 2 campers next to old Grange; received quote from Ag-Pro for new cemetery mower at state bid price of \$8,653.75; current mower purchased in 2006, 16 years old uses quart of oil per day. Trustee Reed will look into purchasing new mower, possible put old mower up for bid. Trustee McMahan stated campers reported to Sheriff's department.

OLD BUSINESS: Trustee Reed still looking into First Energy SR 534 and SR 166 partial refund; waiting on county engineers quotes for Hoffman's ditching, tree removal and culvert replacement, for Boughner applying stone then MC-70; get prices for septic system cleaning and inspection. Chairman Morse look at Atkins road. Trustee McMahan commented on memorial design available next meeting with benches, engraved standing stones, selling bricks, engraving names; contact someone place logo on floor; will talk to county engineer on Mechanicsville and Trask covered bridges.


NEW BUSINESS: Trustee Reed cancelled ordering 2022's stone bid balance of 700-ton of #411 limestones, will wait to order after 2023's stone bid is awarded. Trustee Reed moved to

advertise for 2023 stone bid of 2,500 ton of #411 limestones, bids to be opened on April 5, 2023 at 8:00 p.m., seconded by Chairman Morse, 3 ayes, motion carried. Chairman Morse suggested having health department inspect township facilities. Trustee Reed reported still working on Ash. Co. Solid Waste Management reimbursement grant for general collection event and township spring cleanup timing.

FISCAL OFFICERS' REPORT: The Fiscal Officers' financial reports and document reflecting timely payment of Township bills were reviewed. Chairman Larry Morse moved to approve the Fiscal Officer's financial reports, seconded by Trustee John McMahan, 3 ayes, motion carried. The Fiscal Officer distributed proposed Permanent Appropriations for review by the Board. After the Board reviewed the Permanent Appropriations, Trustee McMahan moved to accept the Permanent Appropriations as presented, seconded by Trustee Reed, 3 ayes, motion carried. The Fiscal Officer reported award notification from NOPEC Community Event Sponsorship Program of \$250.00 deadline April 30, 2023. Trustee McMahan moved to award the Community Event \$250.00 to the Trumbull Township Fire Department Auxiliary, seconded by Trustee Reed, 3 ayes, motion carried. The Fiscal Officer reported WLE Trucking's quote for a 4-yard container 2 times per month for \$94.66 and 4 times per month for \$116.87 with no additional fuel expense. Trustee Reed moved to approve hiring WLE Trucking for garbage pickup 2 times per month, seconded by Trustee McMahan, 3 ayes, motion carried.

The Chairman opened the floor for comments from others in attendance who desired to speak. Mr. Day stated reached out to county prosecutor five times with no response; will move forward with plan, start to sell wine, contacted privacy attorney regarding Zoning Administrator Niewiadomski's email information without my consent. Zoning Administrator Niewiadomski stated permit information is public record.

Chairman Larry Morse moved to adjourn the regular meeting, seconded by Trustee McMahan, 3 ayes, motion carried.
