ZONING ADMINISTRATOR: Niewiadomski talked with Tony Trianfante of Kuhnle Motor Sports requiring a driveway permit for a grass field overflow parking lot not for truck pulls or semi's with limited use and special events parking, beyond that it won't comply with zoning regulations; will issue violation to 4564 Footville-Richmond road resident for lawn sales; talked with Hoffman road resident regarding mother-in-law suite in large garage separate from house, enforcement an issue; junk vehicle issues on SR 534 or State not being followed up on or enforced, not getting help from County Prosecutor; will reach out to County Health Department regarding Hey Now issue; Trumbull Center Cemetery Vault roof shingles need replaced; voiced his concerns regarding issuing violations that aren't a deterrent, aren't enforced, asked what additional steps can be taken. Trustee McMahan stated follow through with second or third violations, check with county prosecutor for legal advice or documents, and check with other townships procedures or fees.

ZONING COMMISSION: Commission Member Loya reported the next meeting is scheduled for May 15, 2023 at 7:30 p.m. at TTAB.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported receiving 11 calls in April; equipment in good shape; next year radios being phased out new MARCS system \$700-\$800 each radio; Captain Morse will attend VFIS Updated Drivers Instructors Certification in August to be held in Wayne County; obsolete listed items have been removed; received quote from Northeastern Communications for Kenwood Radio including installation and programming for #252 Engine costing \$3,437.53. Trustee Reed moved to approved the purchase of the Kenwood Radio, seconded by Trustee McMahan, 3 ayes, motion carried. Assistant Chief Rose talked to Signsations regarding applying Engine #252's decal problem, decals will be replaced.

The Board discussed the Fire Department memorial options; dust control applying material option too expensive, best option road projects, additional levy on ballot; hanging township logo in hall; repair broken cemetery head stones; hall backup generator can't get replacement parts, hard to find new generator do to demand with Ukraine conflict, cost \$30,000 - \$40,000, FEMA Preparedness Grant 12 weeks out, tabled for further discussion.

NEW BUSINESS: None.

FISCAL OFFICERS' REPORT: The Fiscal Officers' financial reports and document reflecting timely payment of Township bills were reviewed. Trustee Reed moved to approve the Fiscal Officer's financial reports, seconded by Trustee McMahan, 3 ayes, motion carried. The Fiscal Officer presented AG-PRO's Quote for X590 Lawn Tractor with 48" mower deck of \$6,718.47, unknown when unit will be available will look into.

The Chairman opened the floor for comments from others in attendance who desired to speak. Bruce Johnson and Sue Hunt stated their concerns regarding Kuhnle's environmental ditching and water plan, no business plan recorded with Ashtabula County Soil & Water, 2 counties effected Ashtabula & Geauga, 2nd violation issued by Geauga. Zoning Administrator Niewiadomski stated property is not commercial, business plant not required by zoning text, check into conditional use permit requirements. Trustee Morse stated Kuhnle's plan is to disc field, roll out, mow and maintain for parking.
