Chairman Morse moved to approve the minutes as presented with corrections of the Board's regular meeting held on August 16, 2023, second by Trustee Reed, 3 ayes, motion carried.

NAD: Trustee McMahan no reports presented.

ZONING ADMINISTRATOR: Chairman Morse read Adam Niewiadomski's report emailed to the Fiscal Officer reporting no transient vendor application submitted; received call from Robert Gurkin of 3217 Mechanicsville road concerning neighbor Chris Shields of 3203 Mechanicsville road installing fencing and shrubs, met with both residents reviewed current fence regulations, matter was resolved.

ZONING COMMISSION: Commission Member Loya reviewed meeting dates, had short meeting on August 21, 2023; Public Hearing scheduled for September 11, 2023 at 7:30 pm at TTAB to present proposed changes and/or additions to zoning regulations; possible meeting on September 18, 2023; meet with County Planning Commissioners on September 27, 2023 to review proposed changes to zoning text.

BOARD OF ZONING APPEALS: Fiscal Officer reported organizational meeting was held on September 6, 2023 at 6:30 pm at TTAB as advertised in the Star Beacon.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported Captain Frank Rosier resigned as a volunteer firefighter will continue to service as Fire Inspector for Trumbull Township Fire & Rescue; presented employment application for fire department chaplain from Richard Benelewsk to serve only as Chaplin; #252 Engine decal letters installed; received 3 fire calls last month; 1 volunteer fire fighter out with COVID; received #251 Engine repair parts; after the Board reviewed In Command Coaching & Consulting, LLC's grant writing service agreement for Trumbull Township Fire & Rescue, Trustee Reed moved to accept the agreement, second by Trustee McMahan, 3 ayes, motion carried. Fiscal Officer to email signed agreement to In Command Coaching & Consulting Trustee Reed moved to approved Richard Benelewski as Chaplin, second by Trustee McMahan, 3 ayes, motion carried.

ROAD AND BRIDGE: Superintendent Sypniewski reported ongoing grading, ditching and mowing of township roads; Kirk road sign missing; possibly next week start Hoffman road project mark trees, clean rite-of-way; asphalt grindings to be used for driveway base; seeing digging in rite-of-way at 4755 Hoffman road possibly undermine road pavement, Chairman Morse stated he told resident to stop digging in rite-of-way; Chairman Morse proposed contacting county prosecutor office to request sending letter to resident; concerning SR534 bridge construction Trustee Reed had County Engineer look at Trask road bridge due to increased traffic stating bridge is ok; Chairman Morse contacted ODOT regarding applying dust control for Trask and

Riverdale and adding more detour signs for Barrett road; Fiscal Officer presented Mr. Accettola's email regarding requesting about 60 (sixty) tons of fill dirt from Hoffman road ditch cleaning, Trustee Reed stated will contact Mr. Accettola regarding request and ditch material will be dumped at the cemetery until further notice.




OLD BUSINESS: None
