

Chairman Larry Morse called the regular meeting of the Board to order at 8:00 p.m. Trustees Larry Morse, Mark Reed, John McMahan and Fiscal Officer Marie Rohrbaugh were also present. The Pledge of Allegiance was recited.

Chairman Morse moved to approve the minutes as presented of the Board’s regular meeting held on September 6, 2023, second by Trustee Reed, 3 ayes, motion carried.

ZONING ADMINISTRATOR: Niewiadomski reported issued agricultural exemption to 4280 Riverdale road to Paul Bylik for maple syrup production; issued zoning violation to 4564 Footville-Richmond road to Dave Salyers for excessive trash; violation mailed to Sharon Kemp 4502 Footville-Richmond road received in error sold property, current property owner unknown; County Prosecutor O’Toole issued agricultural exemption to Mr. Day’s winery; reached out to Kuhnle’s regarding regulations for tractor pulls, 4-wheeler race track and overflow parking use; recommended removing Trumbull Township’s Transient Vendor Resolution, changing Zoning Text regarding Conditional Use Permits issued by Board of Zoning to Zoning Administrator. Trustee Reed read ORC Section 505.94 regarding Registration and Regulation of Transient Vendors. Trustee McMahan stated need to know who is coming into township.

ZONING COMMISSION: Commission Member Loya reported meeting scheduled with County Planning Commissioners on September 27, 2023 at 3:00 p.m. to review proposed recommendations to township zoning text.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported received Marcs radio for #253 Engine, possibly get undercoated; all engine decals installed; one fire call this month. Assistant Chief Rose reported working on required fire department records to In Command Coaching for (AFG) Assistant to Firefighter Grant; working on Bureau of Workers Compensation (FEEEG) Grant. Fiscal Officer reported provided financial records and GoFema account access to In Command Coaching for AFG grant. Chairman Morse took Engine# 251 out of service; donated battery charger and \$150.00 worth of printer ink to fire department.

ROAD AND BRIDGE: Superintendent Sypniewski reported Hoffman road ditching northside half done, ditching dirt dumped in cemetery, next week continue ditching and tree removal; White road chip and seal complete; Boughner MC-70 apply in next 2 or 3 weeks. Chairman Morse reported ODOT applying more calcium chloride to roads for dust control while SR534 bridge is closed, residents taking pictures and crossing barriers; Kuhnle’s having big-rig truck pulls October 6, 7, 8 and 9th, suggested to close road, not enough signs posted for drag strip. Trustee Reed to reach out to residents regarding picture taking and crossing barriers at SR534 bridge, Hoffman road letter delivered to residents.

Mr. Accettola stated he disagreed with September 6, 2023 trustee approved meeting minutes regarding his digging in rite-of-way possibly undermining the road pavement. Mr. Day stated he is happy with outcome regarding his winery. Jennifer Wagner commented on the Fire Department Memorial misspelled name. Trustee Reed stated the Memorial was a beautiful donation from Trustee McMahan. Trustee Reed stated he will be providing a Halloween Event at the Township Hall on Sunday, October 22, 2023 from 5:00 p.m. to 7:00 p.m. at his own expense.
