TRUMBULL TOWNSHIP FIRE AND RESCUE: Assistant Chief Rose reported receiving 2 calls; one electric motor, one tree down on Callahan; work on MABBAS boxes and Active911 dispatch departments; requested replacing Engine #261 lettering with #252 lettering. Chairman Morse reported replacing a broken belt on new compressor; completed Engine #251 maintenance inventory; requested Fire Chief to purchase pressure washer from Home Depot for \$265.00.

ROAD AND BRIDGE: Chairman Morse reported road equipment and maintenance were ongoing.


