

Chairman Larry Morse called the regular meeting of the Board to order at 8:00 p.m. Trustees Larry Morse, Mark Reed, John McMahan and Fiscal Officer Marie Rohrbaugh were also present. The Pledge of Allegiance was recited.

Chairman Morse moved to approve the minutes correcting the word issued to authorized as presented of the Board's regular meeting held on September 20, 2023, second by Trustee Reed, 3 ayes, motion carried.

NAD: No report.

ZONING ADMINISTRATOR: Niewiadomski reported a resident inquired on planning stage for mother-in-law suite; Atkins road seen driveway culvert work been done by Jemm Construction though no Highway Use Manual driveway permit applied for.

ZONING COMMISSION: Chairman Sarah Hammers reported met with County Zoning Commission on September 27, 2023 to review proposed changes/additions to zoning text; next meeting scheduled for October 16, 2023 at 7:30 p.m. at TTAB to review and finalize proposed zoning text changes to send to the Board on October 18, 2023; County Prosecutor O'Toole start having monthly meetings with zoning commissions.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported Engine #251 back in service; Spaghetti dinner went well. Chairman Morse received tanker valve kit will work on installing.

ROAD AND BRIDGE: Superintendent Sypniewski reported continue to maintain and fill potholes except Riverdale and Trask roads due to state applying dust control; Atkins culvert installed 12" should be 15"; Hoffman road northside ditching 99% complete, work on removing trees next; Hoffman road gas line on Hartsgrove's side needs located call a locating company to locate or remove pipe; 5530 Hoffman road right-of-way agreement outlet ditch needs upsized contact county; Trustee McMahan stated trustees couldn't review Atkins road culvert no permit was issued. Chairman Morse stated Atkins road culvert installed above ditch; SR534 bridge possibly open next week; Boughner road MC-70 application in a couple of weeks.

OLD BUSINESS: Trustee Reed to reach out to county prosecutor regarding Mr. Accettola's culvert issue.

NEW BUSINESS: Trustee McMahan inquired regarding Khule on Sullivan road growing activity doing what they want; read ORC 5515.04 regarding signs in the right-of-way then Trustee McManhan made motion to have signs, not Fire or EMS, removed from right-of-way, there was no second; Trask road resident car ran off road, speed posted 20 MPH; asked Fiscal Officer if Trustee Reed or Morse donated any money back to township funds, Fiscal Officer answered no. Fire Chief Berlinski stated Trustee Morse putting a lot of time maintaining fire department

trucks, not enough in budget to pay for what is needed. Niewiadomski stated no plan received from Khule regarding upcoming weekend event, many promises broken, will reach out to Khule race track manager and owner and County Prosecutor O'Toole.

FISCAL OFFICERS' REPORT: The Fiscal Officers' financial reports and document reflecting timely payment of Township bills were reviewed. Chairman Morse moved to approve the Fiscal Officer's financial reports, seconded by Trustee McMahan, 3 ayes, motion carried. Chairman Morse approved the Fiscal Officer's proposed Re-appropriations request #2023-06, second by Trustee Reed, 3 ayes, motion carried. Trustee Reed moved to approved the Fiscal Officer's Then & Now purchased order #45-2023, second by Chairman Morse, 3 ayes, motion carried. The Fiscal Officer reminded fire chief January 2023 inventory still not complete.

The Chairman opened the floor for comments from others in attendance who desired to speak. Jean Mihitsch asked why only 2016 financials are posted to township web site, why nothing more recent? Fiscal Officer answered I only maintain the township website postings are made at trustee's request, Fiscal Officer handed resident public records request form. Sue Hunt commented on zoning violations issued, driveway culvert permits not getting issued, not getting any help from county prosecutors, no police force, why have policies if not followed, find a way, go public with problems.

Chairman Morse moved to adjourn the regular meeting, seconded by Trustee Reed, 3 ayes, motion carried.
