TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported 1 call last month for tree down. Assistant Chief Rose reported on Bureau of Workers Compensation (FEEEG) Grant needing a new protective gear quote from Fire Force Inc./Eagle Emergency for 4 new sets of turnout gear for same amount and items as first quoted. Chairman Morse reported working on an ODNR Grant with 50/50 match for headache rack and tool boxes; everything up and running, start working on Engine #252, may take out of service; possible \$15,000 equipment grant from Ohio Department of Commerce in spring; 1 open burn call tonight.

ROAD AND BRIDGE: Superintendent Sypniewski reported working on topping off Boughner road driveways; Hoffman road still working on ditching and tree removal; International Truck #1 having heater trouble asked Chairman Morse to look at; continue with on-going routine road maintenance, fill holes, etc.
