

Chairman Morse called the regular meeting of the Board to order at 8:00 p.m. Trustees Mark Reed, John McMahan, and Fiscal Officer Marie Rohrbaugh were also present. The Pledge of Allegiance was recited.

Chairman Morse moved to approve the minutes as presented with changes of the Board's regular meeting held on January 4, 2022, second by Trustee John McMahan, 3 ayes, motion carried.

NAD: No Report.

ZONING ADMINISTRATOR: The Chairman reported no zoning fee amount listed on 1351 Schedule of Zoning Fees for less than 1200 square feet additional commercial zoning fee. Chairman Morse moved to approved the cost of the County Prosecutor's publishing the notice of hearing once per week for six weeks regarding Case #2021 CV 00393 Judgment Entry to David Gentry not to exceed \$400.00, seconded by Trustee Mark Reed, 2 ayes, motion carried.

ZONING COMMISSION: No Report. Next meeting is 2/21/2022 at 7:30 p.m. at the TTAB.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Trustee Mark Reed and Trustee John McMahan volunteered to serve as the Boards legislative representatives for the Volunteer Firefighter Dependent's Fund. The Fiscal Officer will contact the Fire Chief to appoint the members to the Fire Department.

ROAD AND BRIDGE: The Board discussed the 2022 stone quantity. Trustee Mark Reed moved to publish notice for stone bids to be opened on March 16, 2022 at 8:00 p.m. for the purchase of 2,500 tons of #411 Limestone for use on township roads delivered to the road garage yard, subject to the Board's right to refuse all bids, seconded by Chairman Morse, 3 ayes, motion carried. The Road Superintendent presented snow plow repair quotes from Phillips Welding \$2,953.00, Sherman's Welding \$1,941.46 and J M & J Welding \$1,334.38. After Board discussion, Chairman Morse moved to approved J M & J Welding Quote of \$1,339.00, seconded by Trustee Mark Reed, 3 ayes, motion carried. The Road Superintendent reported a Hoffman Road resident drained pond water into road ditch. The Road Superintendent reported snow plowing issues regarding residents not pushing snow far enough across the roads into the ditches.

OLD BUSINESS: Trustee Mark Reed reported First Energy costs to install a new led light pole at 534 & 166 costs of 3,500 to 5,000 and using existing pole would cost 2,000 to 3,000. Trustee John McMahan talked with Ohio & County regarding blinking stop sign at 534 & 166. Chairman Morse will continue talking with Dave Castrilla & NEO to trade-in excess light fixtures, old fixtures have been disposed of. Chairman Morse waiting on gutter quotes. Trustee Mark Reed waiting on Rockwell's gutter quote.




Trustee John McMahan commented on Bookmobile stops at Township Hall and Park, Cemetery issues repair of cemetery stones, Riverdale Cemetery fence maintenance, Old Township Hall in great shape needs minor siding/window repairs, maybe rent out, limited parking area, get grants for repairs or moving building. Trustee John McMahan asked Chairman Morse to address his Fire Department concerns. Chairman Morse stated he met with the Fire Chief regarding nothing getting done, not maintaining equipment, trucks not washed covered in salt, floors and bathroom dirty, testing not done on pumps, trucks, hoses, air packs, air compressor, not keeping records, no volunteer firefighters from Trumbull Twp., Fire Chief not doing job description, if you don't have the time, not going to do the job, why don't you quit. Mr. Clay responded the Chairman said you're going to resign or I will see you fired. Chairman stated he didn't say that. Mrs. Accettola stated not concerned about dirty floors or volunteer firefighters not being from Township, concerned about response to fires, she requested the Fiscal Officer's public records form, the Fiscal Officer gave her the form. Mr. Clay stated communities fault no firefighters from township. Mr. Clay requested the Fiscal Officer's public records copies of rosters and runs when Chairman Morse was Fire Chief. Trustee Mark Reed questioned why Trumbull Township not getting called to recent SR 534 fire and others.

NEW BUSINESS: None.

Fiscal Officers Report: The Fiscal Officers' financial reports and documents reflecting timely payment of Township bills were reviewed. Trustee John McMahan moved to approve the Fiscal Officer's financial reports, seconded by Chairman Larry Morse, 3 ayes, motion carried. Chairman Morse moved to approve the Fiscal Officer's proposed Then & Now Purchase Order #17-2022, seconded by Trustee John McMahan, 3 ayes, motion carried.

The Chairman opened the floor for comments from others in attendance who desired to speak. Mrs. Knauff commented on condition and lighting of flags. Mr. Accettola verify Fire Department Roster members and when was last Fire run.

Trustee John McMahan moved to adjourn the regular meeting, seconded by Trustee Mark Reed, 3 ayes, motion carried.
